### ONE TIME ENROLLMENT PAYMENT

<b>Application Fee</b>	Rs. 1,000/- (Rs. One thousand only) One time payment at the time of admission, <b>Non Refundable</b>
<b>Enrollment Fee</b>	Rs. 30,000/- (Rs. Thirty thousand only) One time payment at the time of admission, <b>Non Refundable</b>
<b>Caution Deposit</b>	Rs. 10,000/- (Rs. Ten thousand only) One time payment at the time of admission, <b>Refundable</b>

### COMPREHENSIVE SESSION FEE

<b>Academic/Tuition Fee</b>	Rs. 90,000/- (Rs. Ninety thousand only) To be paid in four installments.
<b>Annual Charges</b>	Rs. 1,900/- (Rs. One thousand nine hundred only) To be paid in four installments.
<b>Meal Charges</b>	Rs. 17,500/- (Rs. Seventeen thousand five hundred only) To be paid in four installments.
<b>Transportation Fee</b>	Rs. 28,000/- (Rs. Twenty Eight thousand only) To be paid in four installments. Transport charges are applicable for those opting for school transportation services

- Parents may purchase school uniforms, textbooks, notebooks, and other educational materials from the market.
- The school management reserves the right to review and revise the academic fee by 5% to 10% annually to reflect changing operational costs and maintain the quality of education and facilities.
- The fee for the academic session 2025-26 is applicable for 10 months and is payable in four installments.
- The school transport service is provided as an option and is not mandatory. The transportation fee will be linked to changes in the price index, fuel costs, and other external factors, and may be revised at the beginning of each academic session as determined by the School Management. Mid-quarter changes or cancellations of the transport service will not be permitted once opted for.
- Mess services are provided to ensure a healthy and balanced diet for all students. Participation in the mess program is mandatory to maintain uniform dietary standards. Mess fees are reviewed annually and may be adjusted based on cost changes.
- A late fee of ₹30 per day will be applicable for payments made after the due date. If the fee remains unpaid for more than 90 days, the school reserves the right to take disciplinary action, which may include suspension of services or removal of the student's name from the school register until dues are cleared.
- Any applicable taxes, such as GST or other levies imposed by Local, State, or Central Government authorities, will be borne by parents.
- Admission Fee, Registration Fee, and other specified non-refundable components will not be refunded under any circumstances, including withdrawal or cancellation of admission after the completion of admission formalities.
